## Tackling Transportation

NCLA REGIONAL ISSUES SUMMIT NOVEMBER 10, 2020

#### **NCLA PRIORITY:**

Secure the funding to widen I-25 to three lanes each way between Highway 14 in Fort Collins to Highway 66 north of Longmont by 2025.

#### NCLA supports:

- dedicated transportation funding of \$300M in the state's General Fund
- encourage voter approval of a transportation bonding program
- protect funding already committed to widen I-25
- work to identify new transportation funding sources that are politically viable
- advocate for the state to use the last tranche of funding from Senate Bill17-267 and any future available funds for completion of the state's major transportation corridors
- Support improvements to secondary roads in the two-county region that improve mobility



#### Percent Change in Vehicle Miles Traveled, Population, and State Highway Lane Miles - 2017




Over the past two decades, population and vehicle miles traveled (VMT) have increased more than 25 percent, while total highway lane miles have remained relatively constant.

### Why are we here?

#### NOT KEPT UP

• I-25 Longmont to Fort Collins lacks adequate capacity due to lack of state funding. Original concrete put down in 1968

#### POPULATION GROWTH.

• Since North I-25 built, population of two counties 4X. By 2040 +52% Larimer, +111% Weld


#### EXPENSIVE.

Additional lanes each way Hwy 14 to Hwy 66 ~\$1.7B

#### • NOT A BIG PRIORITY FOR STATE ELECTED OFFICIALS.

Have had to fight to get any funding from General Fund

#### UNTIL 6 YEARS AGO NO ORGANIZED ADVOCAY / LOBBYING EFFORT




## Our Results to Date Secured ~\$1.2B for North I-25

- Work is underway to add a 3rd lane both directions Harmony Road in Fort Collins and Highway 402
- Berthoud Hill Climbing Lane
- Crossroads Bridges and Intersection
- Highway 402 interchange rebuilt and reopened October 2019
- Prospect interchange being rebuilt
- Work started in fall 2019 on the section of I-25 south of 402

### Help State Fix its Funding Problem

- A guiding philosophy of Fix North I-25 from beginning:
  - We cannot fix our problem on I-25 without helping the state fix its transportation funding problem
- Created Fix Colorado Roads
  - Built momentum and positioned as a go to leader on funding transportation
- Persistent, ever present advocate for transportation funding
  - Helped secure incremental funding wins of over \$3.75B of general funded or financed dollars to transportation statewide since our inception
- Catalyst for referred measure proposals and ballot questions
- Strong and consistent advocate for Legislature committing General Fund monies to transportation. \$800 M alone secured for FY 2019-20.

- SB 19-262 \$60M (one time)
- SB 19-263 \$1B (20-year, \$50M/year)

#### The Future

- General Fund Monies
- Identify politically and financially viable new revenue streams
  - Electric vehicles, gas tax, other sources
- Federal Infrastructure Funding
- Protect hard-earned capacity of express toll lanes from free usage by electric vehicles
- Begin to consider local funding mechanisms like regional transportation authorities
- Bonding
