<p>What are the top two issues facing city government over the next 4 years and why do you believe they are the most important?</p>	<p>Covid has negatively impacted the physical, mental and economic health of Fort Collins. Because they are so interconnected recovery from those impacts is a significant hurdle that we must address immediately.</p> <p>Fort Collins is growing fast and creating a viable strategy to allow that growth to happen while mitigating as many negative impacts as possible is another high priority. While the final vision of that plan may take another decade or two to be fully realized, the framework needs to be set within the next few years.</p>
<p>What economic tools should the City add to their "tool box" of resources to attract key employers?</p>	<p>I think that the world is going to see some significant innovations related to transportation (especially in the aerospace sector) in the next decade or less. These will likely be innovations that we can't even comprehend yet today. The investment that Fort Collins is currently making in the Fort Collins/Loveland airport could be leveraged to attract employers related to these new industries.</p>
<p>What are the top three transportation improvements the City of Fort Collins should accomplish? What is your position on the Fix North I-25 effort? Why?</p>	<p>The improvements to I-25 are long overdue and important as the northern Colorado region grows. Continuing collaboration on this project should be a priority.</p> <p>287 has more-or-less reaches its expansion and build out limitations. It will be important to begin planning for another north-south route of equal capacity before</p>

	<p>287 reaches its maximum designed traffic volumes. This is a long range concern that can begin by addressing some more acute traffic issues such as constructing an grade separated crossing at Lemay and Vine.</p> <p>Expanding the Max service to include an east-west component. Consideration of this should include expansion into a regional service to help mitigate traffic from our growing neighbors.</p>
<p>Tell us about your understanding of water issues in Northern Colorado.</p>	<p>There are numerous communities in northern Colorado vying for water from a limited number of sources. Some communities were more proactive than others in establishing rights to water from those sources. Access to those water rights is often the deciding factor that makes or breaks growth and development in many areas.</p>
<p>What is your position on water storage in northern Colorado? Do you support the NISP project? Do you support the Halligan project?</p> <p>Why do you hold these positions?</p>	<p>Because of the extremely high differential between seasonal high and low flows in our stream and rivers, water storage is essential to ensure a consistent year-round water supply for any community here.</p> <p>Expansion of the Halligan reservoir is taking advantage of an existing infrastructure investment and increasing its capacity. In my opinion this is a very smart move.</p> <p>While the proposed NISP project would significantly increase the water storage capacity of Fort Collins, the negative impacts to the ecological and recreational value of the Poudre River both in the canyon and right in Fort Collins would be</p>

	<p>equally significant. At this point in time I believe it would be in or best interest to put the NISP project back on the shelf for possible reconsideration in the future and use our resources to explore other water storage opportunities.</p>
<p>Why should the members of your district support your election to office?</p> <p>Why should someone who is interested in a vibrant city economy vote for you?</p>	<p>It is a very complex web of interconnected attributes that makes Fort Collins a world class city. Covid and the current political climate, have started to stress many of the connections in that web. We need to mend those ties and build new ones. Too much emphasis or focus on any one of those attributes will jeopardize many of the others. I will listen to all voices, understand those issues, and consider all options to reconnect this community.</p>
<p>Do you have existing relationships with anyone on City Council or Staff? And how will those relationships help you serve the citizens of Fort Collins.</p>	<p>Yes, as a member of the Planning and Zoning Board and as a local architect, Jeff has formed strong professional relationships with City Staff within the Community Planning Department and Building Department. Working closely with those departments often leads to interactions with Council members and with the City manager and his office. These relationships are built on mutual respect, demonstrated by the fact that Jeff has been invited to participate in the interview and hiring process for a few new department managers.</p>
<p>If business groups endorse you, is there any significant information that could come out about you during a campaign that could potentially embarrass you (and them) publicly? (ex: bankruptcy, discrimination, harassment, arrest, conviction, etc.)</p>	<p>I am on my second marriage. I am told that divorce went a lot more smoothly than most. There was a bankruptcy in that first marriage (15 years ago) as a result of some medical debt. I'm not sure if this constitutes "significant information" or not.
