They ensure a functioning work force. <p>Role in economic development – The focus needs to remain on small businesses. There should be a mechanism for small businesses which face difficulties to reach out to the city for financial help, as well as advice on how to weather a difficult period. This is often all that is needed. Budget priority - I will ensure that funds are spent on investing in services for the community which serve the public good.</p>

What are the top two issues facing city government over the next 4 years and why do you believe they are the most important?	<ol style="list-style-type: none"> 1) The fall-out from the pandemic which includes empty buildings and bankrupt businesses. (The Foothills Mall could be an issue depending on what happens with it.) 2) Climate change issues which include forest fires and water will continue to affect our city.
What economic tools should the City add to their "tool box" of resources to attract key employers?	Affordable child care – Portland just passed a ballot initiative which provides preschool for 3- and 4-year-old children. I would like to see something like that pass in Fort Collins.
What are the top three transportation improvements the City of Fort Collins should accomplish? What is your position on the Fix North I-25 effort? Why?	<ol style="list-style-type: none"> 1) One of my biggest pet peeves is how many families in Fort Collins don't use the school bus system. The traffic jams outside of schools is annoying and dangerous. An effort should be made to encourage the use of the school buses. 2) Bike paths have been improved and

One example of this is Shields.</p> <p>3) Railroad crossings continue to be a transportation nightmare. Efforts are taking place on Vine Street. I’m not sure what the solution would be.</p> <p>I am totally in favor of the Fix North I-25 effort. Driving to Denver is dangerous now, and a third lane would make it less of a hair-raising experience.</p>
<p>Tell us about your understanding of water issues in Northern Colorado.</p>	<p>Water is a complex issue which boils down to the fact that you either have enough or you don’t. What makes it sticky is that people located upstream of a water source that is used downstream, can affect the flow of water. An aquifer can be accessed by many landowners and the rate at which individuals land-owners drain the aquifer creates problems. Another complicating issue is the rate of development along the Front Range which will put pressure on the need for water.</p>
<p>What is your position on water storage in northern Colorado? Do you support the NISP project? Do you support the Halligan project?</p> <p>Why do you hold these positions?</p>	<p>Reservoirs are an inefficient way to store water. The surface is greater than a natural lake since the water is shallower making the rate of evaporation higher. When water storage is needed, it should be done below ground. I therefore don’t support the NISP project. The Halligan project looks like it is a better solution since it is an existing reservoir and the surface area won’t increase as much since the height of the</p>
